

**SEPA DETERMINATION OF NON-SIGNIFICANCE (DNS)  
SEATTLE DEPARTMENT OF TRANSPORTATION  
FAIRVIEW AVENUE NORTH BRIDGE REPLACEMENT PROJECT**

**Description of proposal:** The City of Seattle Department of Transportation will replace the Fairview Avenue North Bridge. The existing bridge consists of two parallel timber and concrete bridges that are structurally deficient. The new bridge will be a single concrete structure that maintains existing vehicle lane configurations while providing sidewalks on each side of the bridge and a two-way cycle track on the west side of the bridge. Bridge construction will begin in 2017 and take approximately 15 months. During construction, the bridge will be closed to vehicle, bicycle, and pedestrian traffic, which will be detoured around the project site. Project work will also include replacing the viewing platform north of the bridge with viewpoints along the west side of the bridge, possibly removing an abandoned coal dock, installing stormwater conveyance piping and basic treatment, and removing and, if permitted, relocating the existing floating walkway further west of the bridge. Temporary relocation of transmission lines and detour route preparation work will be performed before bridge construction begins.

**Location of proposal including street address, if any:** The project is located on the section of Fairview Avenue North that crosses the southeast shoreline of Lake Union northeast of Yale Avenue North and southwest of East Galer Street in Seattle, Washington.
