

**SEPA DETERMINATION OF NON-SIGNIFICANCE (DNS)
SEATTLE DEPARTMENT OF TRANSPORTATION (SDOT)
SWIFT AVE S/S MYRTLE ST/S MYRTLE PL/S OTHELLO ST AAC PROJECT**

Description of proposal: The City of Seattle Department of Transportation (SDOT) has issued a Determination of Non-Significance (DNS) in accordance with the State Environmental Policy Act (SEPA) for the Swift Ave S/S Myrtle St/S Myrtle Pl/S Othello St Arterial Asphalt and Concrete (AAC) Project. The purpose of the project is to improve the pavement conditions by replacing the existing asphalt overlay (mill and overlay) and partially reconstructing asphalt/concrete pavement. The project would also improve sidewalks and curb ramps, upgrade pedestrian signals and crosswalks, improve bicycle facilities, replace impacted pavement markings, and improve drainage facilities.

Location of proposal including street address, if any: SDOT proposes to improve Swift Ave S, S Myrtle St, S Myrtle Pl, and S Othello St from 15th Ave S to MLK Jr Way S in the Beacon Hill neighborhood.

Lead Agency: SDOT

SDOT has determined that this proposal would not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(c). This decision was made after review of a completed environmental checklist and other information on file with the lead agency. This information may be examined in the Seattle Department of Construction and Inspections Public Resource Center at 700 5th Avenue, Suite 2000, Seattle, WA, 98104. Documents are also at the Seattle Central Library, at 1000 4th Avenue, Seattle, WA, 98104.

There is no comment period.

This DNS is issued after using the optional DNS process in WAC 197-11-355 and Seattle Municipal Code (SMC) 25.05.355. There is no further comment period on the DNS.

This DNS is issued under WAC 197-11-340(2) and Seattle Municipal Code (SMC) 25.05.340; the lead agency will not act on this proposal for 14 days from the issue date below. **Comments must be submitted by 5:00 p.m. January 25, 2018.**
